To make our position in prophecy and the modern-day fulfillment perfectly clear, there will be no new temple in modern literal Jerusalem today where a pig is sacrificed or some other abomination offered when the latter day BRANCH Temple is built. The “abomination of desolation” of our day, the mark of the beast, is to be nearly forced upon the spiritual corporate body of Messiah, the spiritual temple of today, The BRANCH body, the Wavesheaf Company and the 144,000, the plandemic to desecrate our/their body temples with DNA altering “mRNA” serum. This was Satan’s plan and objective all along so as to destroy the Divine Image in each of our bodies beginning with the very building blocks of biological life – DNA, where the Moral Divine Image, even The Divine Name of the Creator(s), the Tetragrammaton, is written.

The *abomination that causes desolation* is a term used in the Bible to refer to both the Maccabean Wars in Daniel 11:31 and the Jewish War at the end of the age in the remaining verses. During the Maccabean Wars of the second century B.C., the Greeks attacked Jerusalem causing a great slaughter in the city. The Greeks then set up an idol of Zeus (2 Macc 6:1-2) and sacrificed a pig in the Temple in Jerusalem (1 Macc 1:59 Wars 1.1.2).¹ This act is referred to as “a desolating sacrilege” in 1 Macc 1:54 and “the abomination that causes desolation” in Daniel 11:31.



The Aquila was generally depicted holding Zeus' lightning bolt in its claws.

The Romans did almost exactly the same thing in A.D. 70! Upon seizing the Temple, the Romans set up their ensigns on the eastern gate and offered sacrifices to them (Wars 6.6.1).² The main ensign was Aquila, the eagle that carries ZEUS' lightning bolt. Here we see a veritable idol of Zeus like that erected 200 years earlier by the Greek army in the Jewish Temple during the Maccabean Wars. What animals did the Romans sacrifice? Historians believe the Roman army likely sacrificed the *suovetaurilia* in the Temple that day in A.D. 70. The *suovetaurilia* is a ritual sacrifice of three animals: a sheep, an ox and a pig for the purpose of land purification. The *suovetaurilia* was customarily performed for the purification of a Temple that had been destroyed. Did you catch that? The Romans set up a veritable idol of **Zeus** in the Temple and offered a **pig** in sacrifice to it exactly like the Greeks did 200 years earlier which Daniel 11:31 referred to as "the abomination that causes desolation." (1 Macc 1:54, 59; 2 Macc 6:1-2; Wars 1.1.2.)

Thus if it is true that the abomination that causes desolation was originally fulfilled in the setting up of an idol of Zeus together with the sacrificing of a pig in the Temple, and if the Romans did the same thing, it should be no surprise that the same term is used to describe both events." “Which bovine derived materials are used in vaccine manufacture?”

Microorganisms for vaccine manufacture are grown under controlled conditions in media which provide the nutrients necessary for growth. Cow components are often used simply because cows are very large animals, commonly used for food, and thus much material is available. Animal-derived products used in vaccine manufacture can include amino acids, glycerol, detergents, gelatin, enzymes and blood. Cow milk is a source of amino acids, and sugars such as galactose. Cow tallow derivatives used in vaccine manufacture include glycerol. Gelatin and some amino acids come from cow bones. Cow skeletal muscle is used to prepare broths used in certain complex media. Many difficult to grow microorganisms and the cells that are used to propagate viruses require the addition of serum from blood to the growth media.

Do all bovine materials have the same risk of transmitting the BSE agent?

Scientists have found that different bovine tissues contain different amounts of the BSE agent. It is generally believed that the highest amounts of infectivity are found in the brain and spinal cord from animals in the final stages of clinical disease. Some tissues, such as skeletal muscle and milk, have never been shown to have any infectivity. However, the slaughtering and butchering methods used to obtain tissues and prepare materials can affect the amount of infectivity that may be present. Ministers and People to Act in Concert

101. One important part of the work of the ministry is to faithfully present to the people the health reform, as it stands connected with the third angel's message, as a part and parcel of the same work. They should not fail to adopt it themselves, and should urge it upon all who profess to believe the truth.—Testimonies for the Church 1:469, 470, 1867 { CD 74.2}

102. The health reform, I was shown, is a part of the third angel's message, and is just as closely connected with it as are the arm and hand with the human body. I saw that we as a people must make an advance move in this great work. Ministers and people must act in

concert. God's people are not prepared for the loud cry of the third angel. They have a work to do for themselves which they should not leave for God to do for them. He has left this work for them to do. It is an individual work; one cannot do it for another.—Testimonies for the Church 1:486, 1867 { CD 74.3}

A Part of, but Not the Whole Message

103. The health reform is closely connected with the work of the third message, yet it is not the message. Our preachers should teach the health reform, yet they should not make this the leading theme in the place of the message. Its place is among those subjects which set forth the preparatory work to meet the events brought to view by the message; among these it is prominent. We should take hold of every reform with zeal, yet should avoid giving the impression that we are vacillating, and subject to fanaticism.—Testimonies for the Church 1:559, 1867 { CD 74.4}

104. The health reform is as closely related to the third angel's message as the arm to the body; but the arm cannot take the place of the body. The proclamation of the third angel's message, the commandments of God and the testimony of Jesus, is the burden of our work. The message is to be proclaimed with a loud cry, and is to go to the whole world. The presentation of health principles must be united with this message, but must not in any case be independent of it, or in any way take the place of it.—Letter 57, 1896 { CD 75.1}

*"Here are 'the TIMES of refreshing to which the apostle Peter looked forward when he said,' 'Repent ye therefore, and be converted, that your sins may be blotted out [in the **investigative judgment**] when the times of refreshing shall come from the Presence of the Lord; and he shall send Jesus.'" The Great Controversy, 1888 Edition, page 611.*
